

✨ Summary

1. Opening Ceremony and Meeting Declaration •

7. Upcoming Events and Community Engagement •

Lee - 2nd Vice Report - Plans for participating in the Parade of Lights were discussed, including the need for a decorated vehicle and volunteers.

The Chamber of Commerce concert series was mentioned as an opportunity for community engagement, with an invitation for members to attend.

8. Upcoming Events and Fundraising •

Lee - Scott Grasser Celebration of life will be lead by the color guard / honor guard starting at 5:00pm for the event.

Fleet Easton will perform the national anthem and other songs pro bono at the event.

The next karaoke event is scheduled for December 27th, with kitchen hours yet to be determined.

Tim Bryant will perform for \$200, and he has a significant following.

Village Fest has raised approximately \$950 since July, with expectations to exceed \$1,000 by January.

The funds collected from Village Fest will go into the membership account for community outreach.

9. New Year's Party Planning •

Lee - The kitchen is preparing a menu for the New Year's party, with ticket prices expected to be set soon.

A potluck is planned for the day after the New Year's party, coinciding with the first football game.

John - The House Committee is working on finalizing details for the New Year's party. See List.

10. Bylaws Committee Report •

Rusanne - The bylaws committee has completed the new bylaws, which were approved at the department level.

John - The bylaws were sent out to members Of the Executive committee And The Department of California Bylaws Committee without following the proper procedures, which Has caused issues.

Rusanne - A reading of the bylaws is scheduled for December 9th, with suggestions for changes to be considered.

11. House Committee Meeting Schedule •

14. Fundraising and .Financial Decisions •

Garth - A contract is signed for \$65,000 to procure new kitchen equipment, with two bidders providing options.

A motion was made by Garth and second by Kevin to use \$23,000 from an upcoming charity event to pay Down a \$25,000 SBA loan, potentially saving the Legion \$33,000 over ten years.

(Motion Passed)

Rusanne - The importance of negotiating with the SBA for loan forgiveness upon full payment was discussed.

15. Upcoming Events •

The Christmas Day canteen will be closed, but a joint potluck will be held at a local bar, The Hair of the Dog.

Plans for a New Year's Eve dinner are in progress, with menu details pending from vendors.

McArvie - A suggestion was made to auction off a Steve Garvey autographed baseball bat and ball for fundraising.
